Do I have to take a health exam to get coverage?	You may receive coverage without answering any medical questions or providing evidence of insurability if you apply for coverage within 31 days after your eligibility date. If you apply more than 31 days after your eligibility date, your coverage will be medically underwritten. What is my maximum monthly benefit amount?	Your total monthly benefit (including all benefits provided under this plan) will not exceed 100% of your monthly earnings, unless the excess amount is payable as a Cost of Living Adjustment. When would I be considered disabled?	You are disabled when Unum determines that:  • you are limited from performing the material and substantial duties of your regular occupation* due to sickness or injury; and  • you have a 20% or more loss of indexed monthly earnings due to the same sickness or injury.  After 24 months, you are disabled when Unum determines that due to the same sickness or injury, you are unable to perform the duties of any gainful occupation for which you are reasonably fitted by education, training or experience.  You must be under the regular care of a physician.  *Unless the policy specifies otherwise, as part of the disability claims evaluation process, Unum will evaluate your occupation based on how it is normally performed in the national economy, not how work is performed for a specific employer, at a specific location, or in a specific region.
Do I have to pay for the coverage if I become disabled?	You will not be required to pay LTD premiums as long as you are receiving LTD benefits.
Can I receive rehabilitation and return-to-work services?	If you are deemed eligible and are participating in the program, Unum will pay an additional benefit of 10% of your gross disability payment to a maximum of \$1,000 per month.
What else is included with this policy?	Worldwide emergency travel assistance is included with this long term disability plan. Emergency travel assistance is available to you, your spouse* and your dependent children when you travel to any foreign country, including Canada or Mexico. It is also available anywhere in the United States when you travel just 100 or more miles from home.  * A spouse traveling on business for his or her employer is not covered by the

What happens if I die while receiving disability benefits?	Your eligible survivor will receive a lump-sum benefit equal to three months of your gross disability payment if, on the date of your death, you had been disabled for 180 or more consecutive days, and you were receiving or were entitled to receive payments under the plan.  You may request this benefit early if you have been diagnosed with a terminal illness resulting in a life expectancy of less than 12 months, and you are receiving monthly payments. If you choose to receive this benefit, no survivor benefit will be payable to your eligible survivor upon your death.		
Does my plan cover mental and nervous conditions?	Yes. Depending on your plan, the lifetime cumulative maximum benefit period for all disabilities due to mental illness and disabilities based primarily on self-reported symptoms is 24 months. Only 24 months of benefits will be paid for any combination of such disabilities — even if the disabilities are not continuous and/or are not related. Payments may only continue beyond 24 months if you are confined to a hospital or institution as a result of the disability.		
What is not covered?	Benefits would not be paid for disabilities caused by, contributed to by, or resulting from:  • Intentionally self-inflicted injuries;  • Active participation in a riot;  • War, declared or undeclared or any act of war;  • Commission of a crime for which you have been convicted;  • Loss of professional license, occupational license or certification; or  • Pre-existing conditions (see pre-existing condition section)  The loss of a professional or occupational license does not, in itself, constitute disability.  Unum will not pay a benefit for any period of disability during which you are incarcerated.

When does my coverage end?	Your coverage under the policy ends on the earliest of the following:  • The date the policy or plan is cancelled;  • The date you no longer are in an eligible group;  • The date your eligible group is no longer covered;

Who is eligible?	You are eligible for long term disability (LTD) coverage if you are an active full-time employee in the United States working a minimum of 30 hours per week.			
What is my monthly benefit amount?	Voluntary You can elect to purchase a benefit of 60% of your monthly earnings to a maximum of \$5,000.			
How long do I have to wait to receive benefits?	The elimination period is the length of time you must be continuously disabled before you can receive benefits.  You could begin receiving LTD benefits if, after 180 days of disability, you are still disabled (as described in the definition of disability).  No loss of income is required during the elimination period.			
How long will my benefits last?	The duration of your benefit payments is based on your age when your disability occurs. Your LTD benefits are payable for the period during which you continue to meet the definition of disability. If your disability occurs before age 60, your benefits could be payable until you reach age 65. If your disability occurs at or after age 60, benefits could be paid according to a benefit duration schedule.
